**Demurrage** – will be levied when the customer keeps laden containers inside the terminal for longer than the free days and is applicable to all containers that remain at the terminal longer than the free time.

**Detention** – will be levied when the customer does not return empty container for inbound shipment and does not return laden container for outbound shipment within the free days and is applicable to all containers in the customer's custody till it's returned.

Below tariff is in JPY.
